- U.S. Census and Maryland Department of Planning Estimation Data:
 - Between July 2018 and July 2022, the Region 5 population (ages 11-17) increased 4.6% (from 95,603 to 100,027).
- Intake Case Forwarding Decisions (FY 2023):
 - 28.8% of complaints were formaled, while 11.9% were informaled.
- Intake Trends (FY 2021-2023):
 - Total complaints increased 105.3%.
 - The percentage of total complaints authorized for formal petition decreased from 34.7% to 28.8%.
 - Note: Many 2023 cases are still pending court action, so a disposition trend is not presented.
- Detention Risk Assessment Instrument (FY 2023):
 - For Pre-Dispositional Detention admissions with a completed DRAI, 33.3% were High risk, 29.2% were Moderate risk, and 37.5% were Low risk.
- Time Frames Averages (FY 2023):
 - Time from offense to intake referral date was 72.7 days.
 - Time from intake referral date to case forwarding decision was 20.7 days.
 - Time from case forwarding decision to sustained adjudication was 87.2
- Offense Category for Intake Cases (FY 2022-2023):
 - The percentage of Crimes of Violence increased from 10.7% to 11.1%.
 - The percentage of Felonies increased from 5.9% to 8.0%.
 - The percentage of Misdemeanors decreased from 77.5% to 73.3%.
- Commitments for VOP (FY 2021-2023):
 - The percentage of commitments resulting from VOP decreased from 10.9% (5) to 6.4% (5).





 - Between July 2018 and July 2022, the Anne Arundel County population (ages 11-17) increased 5.3% (from 48,763 to 51,323).
- Intake Case Forwarding Decisions (FY 2023):
 - 25.6% of complaints were formaled, while 6.1% were informaled.
- Intake Trends (FY 2021-2023):
 - Total complaints increased 155.7%.
 - The percentage of total complaints authorized for formal petition decreased from 37.9% to 25.6%.
 - Note: Many 2023 cases are still pending court action, so a disposition trend is not presented.
- Detention Risk Assessment Instrument (FY 2023):
 - For Pre-Dispositional Detention admissions with a completed DRAI, 33.3% were High risk, 33.3% were Moderate risk, and 33.3% were Low risk.
- Time Frames Averages (FY 2023):
 - Time from offense to intake referral date was 78.3 days.
 - Time from intake referral date to case forwarding decision was 18.8 days.
 - Time from case forwarding decision to sustained adjudication was 77.1
- Offense Category for Intake Cases (FY 2022-2023):
 - The percentage of Crimes of Violence increased from 10.1% to 10.9%.
 - The percentage of Felonies increased from 4.9% to 5.4%.
 - The percentage of Misdemeanors decreased from 79.7% to 77.0%.
- Commitments for VOP (FY 2021-2023):
 - The percentage of commitments resulting from VOP increased from 6.1% (2) to 6.5% (4).










