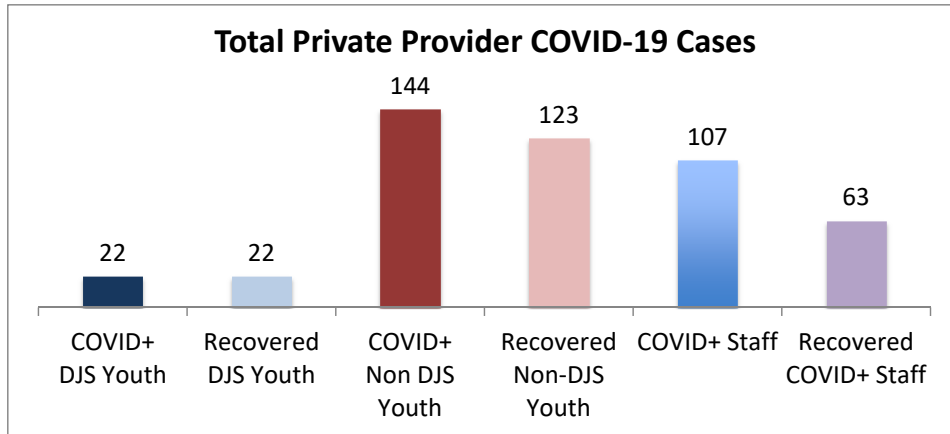


**Overall COVID19 Cases To Date, June 17, 2020**
