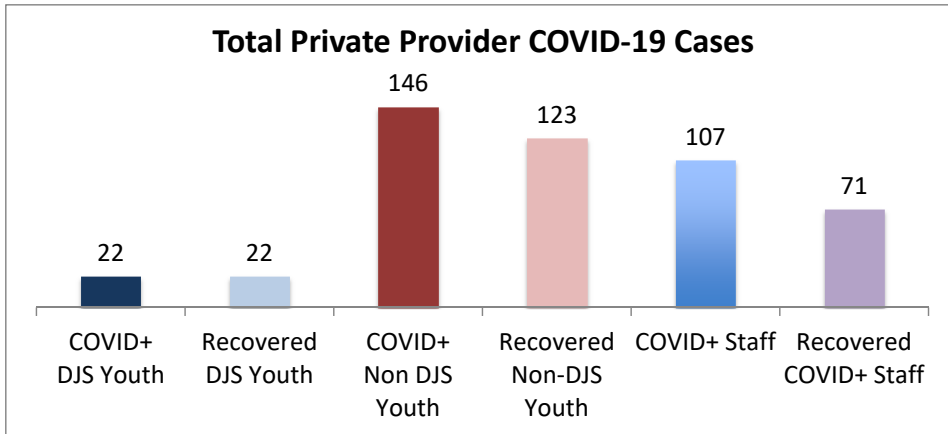


Overall COVID19 Cases To Date, June 23, 2020
