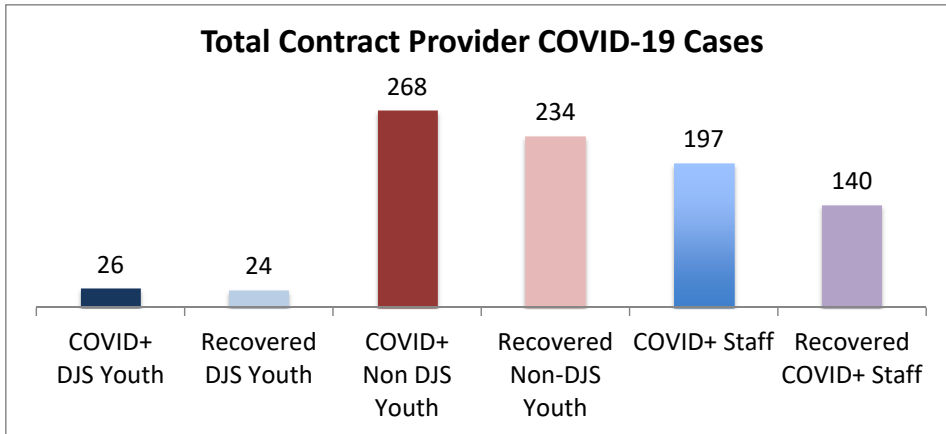




**Overall COVID19 Cases To Date, August 13, 2020**
