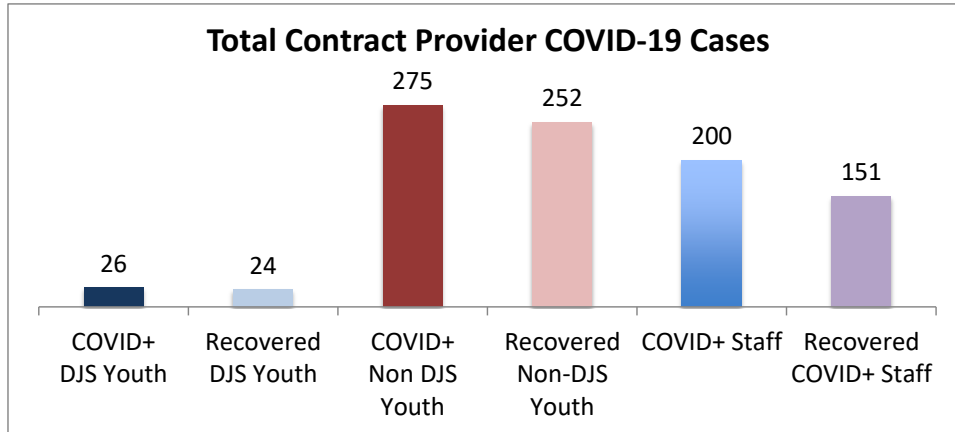


Overall COVID19 Cases To Date, August 18, 2020
