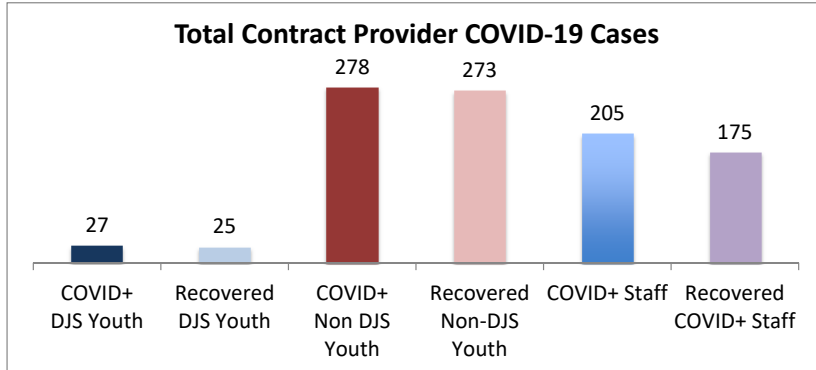


Overall COVID19 Cases To Date, August 31, 2020
