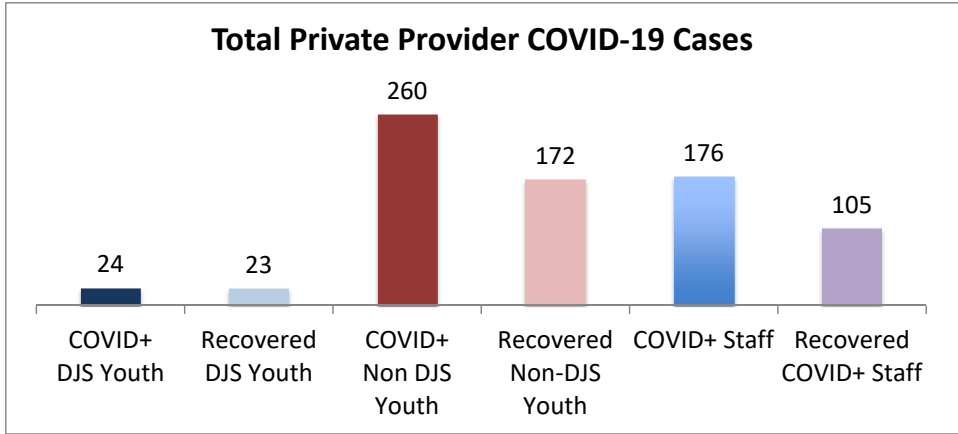




**Overall COVID19 Cases To Date, August 3, 2020**
