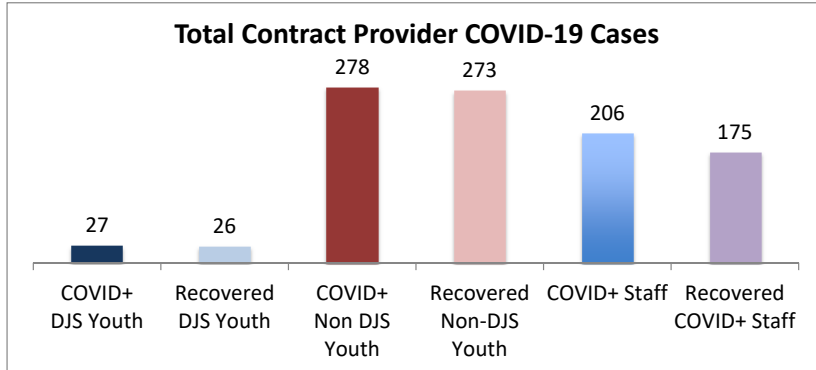


Overall COVID19 Cases To Date, September 3, 2020
