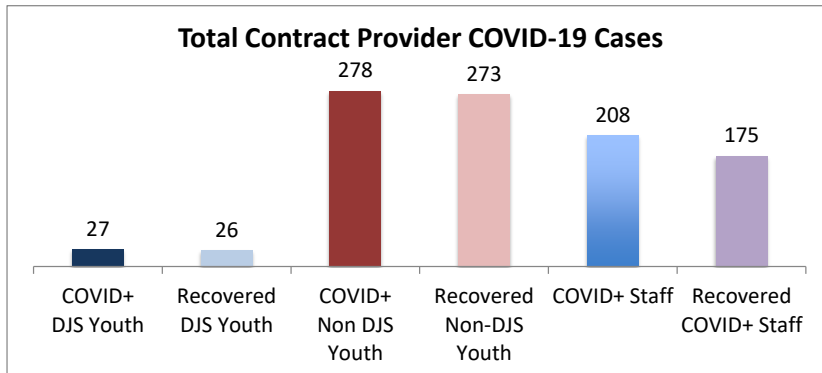


Overall COVID19 Cases To Date, September 4, 2020
