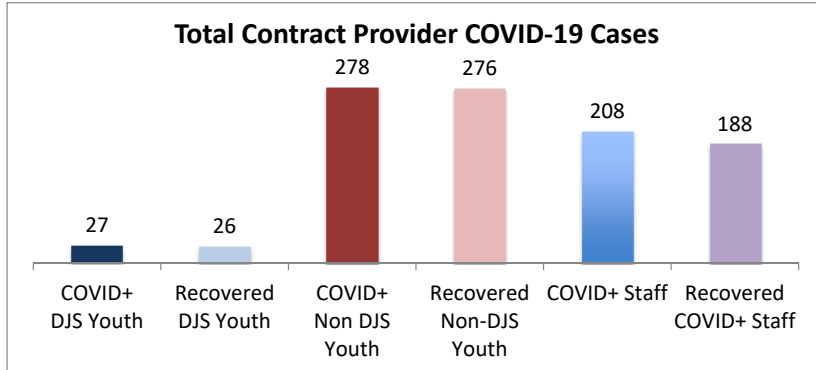


Overall COVID19 Cases To Date, September 8, 2020
