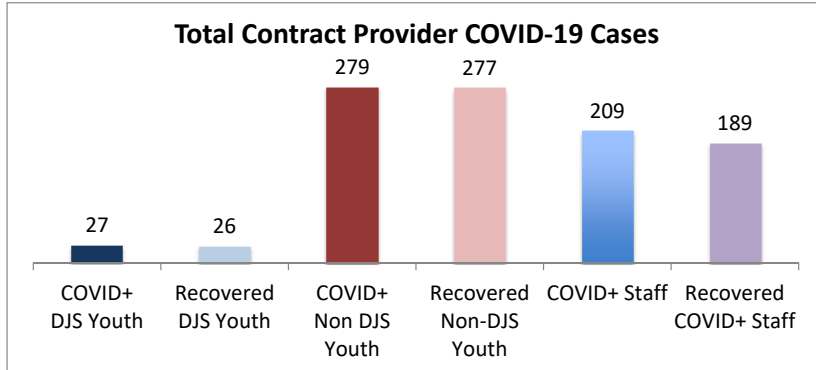


Overall COVID19 Cases To Date, September 10, 2020
