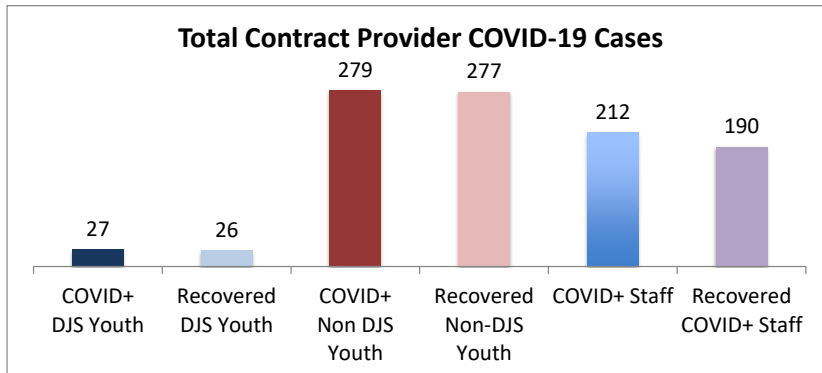


Overall COVID19 Cases To Date, September 14, 2020
