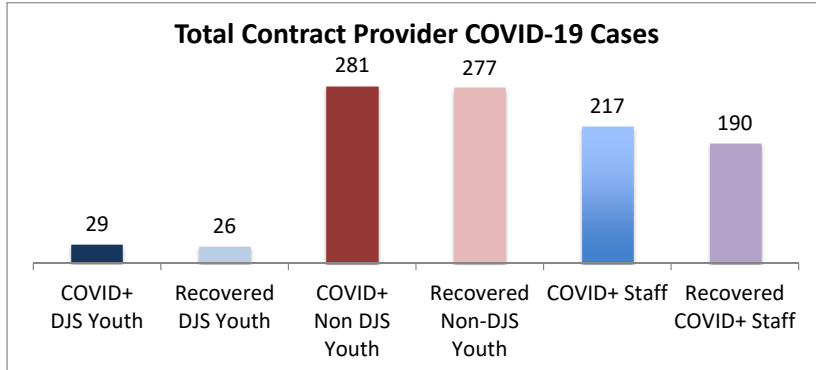


Overall COVID19 Cases To Date, September 17, 2020
