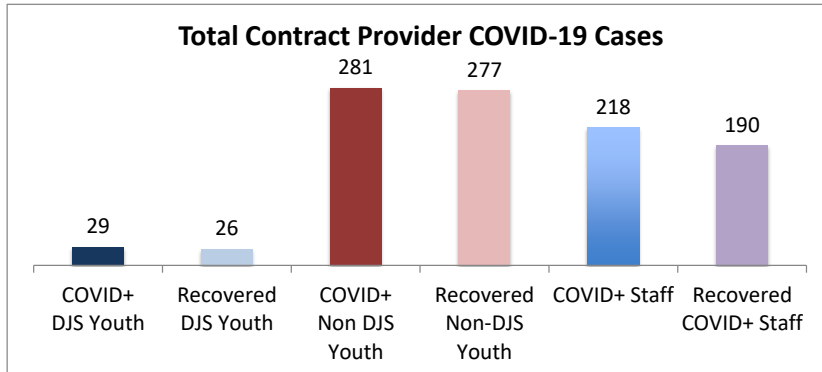


Overall COVID19 Cases To Date, September 18, 2020
