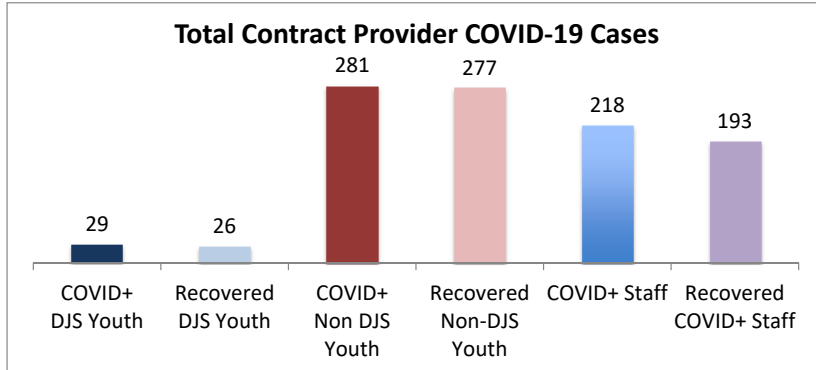


Overall COVID19 Cases To Date, September 21, 2020
