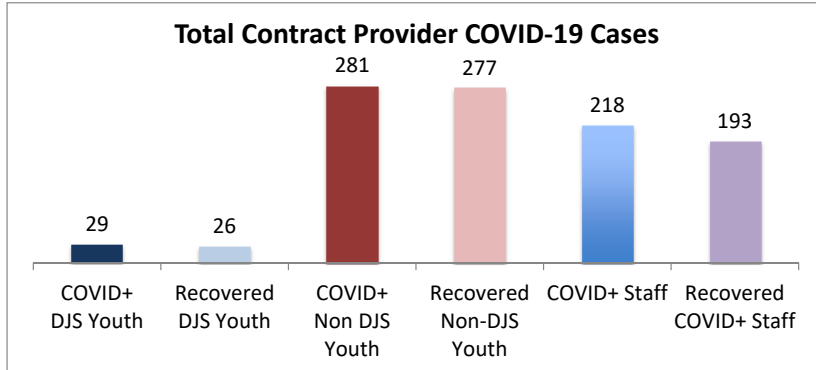


Overall COVID19 Cases To Date, September 23, 2020
