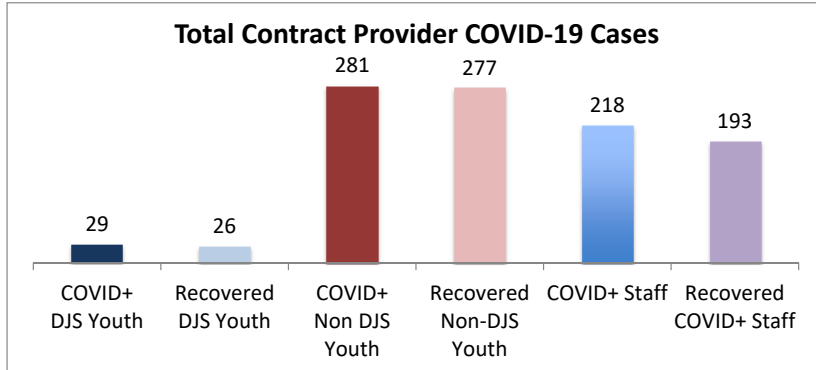


**Overall COVID19 Cases To Date, September 24, 2020**
