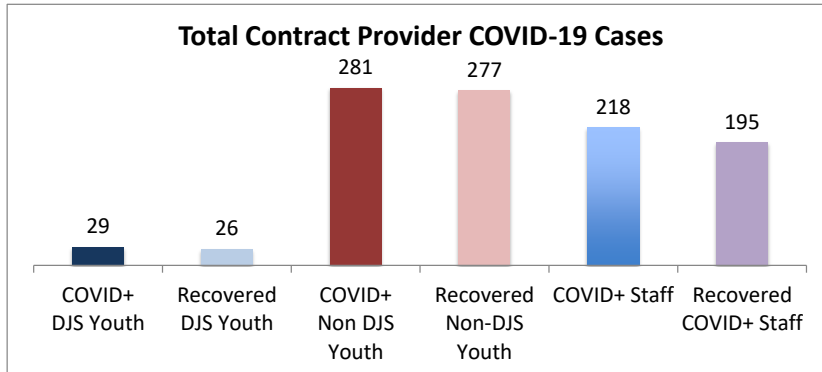


**Overall COVID19 Cases To Date, September 25, 2020**
