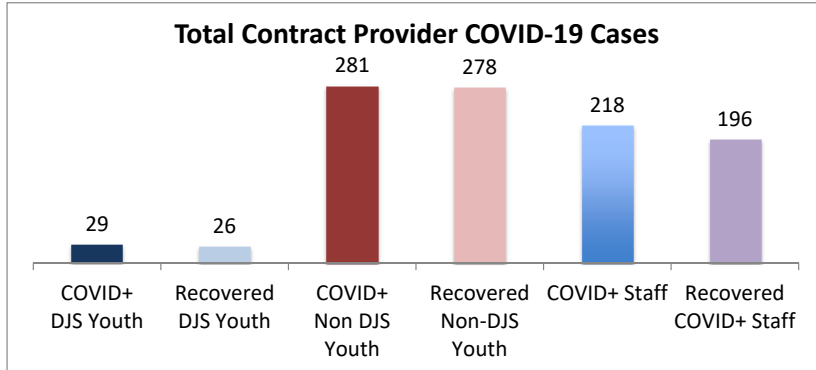


**Overall COVID19 Cases To Date, September 28, 2020**
