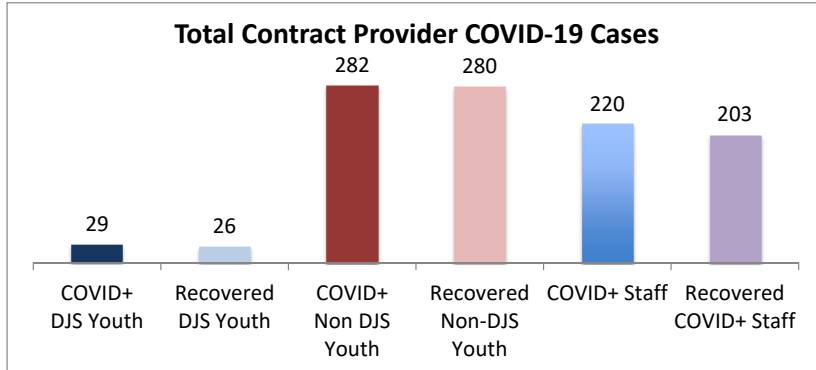


**Overall COVID19 Cases To Date, October 5, 2020**
