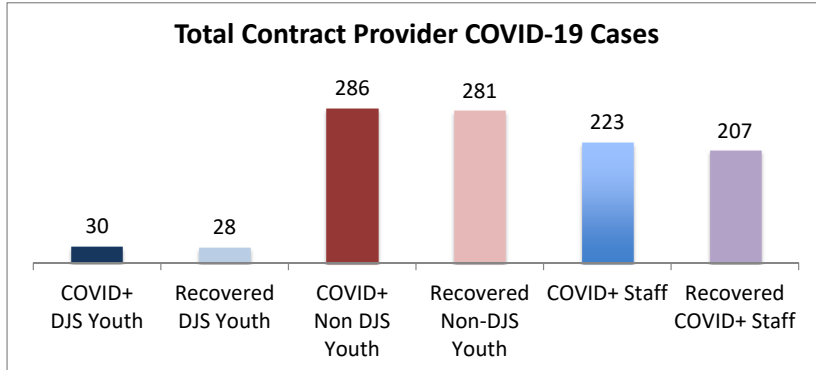


Overall COVID19 Cases To Date, October 14, 2020
