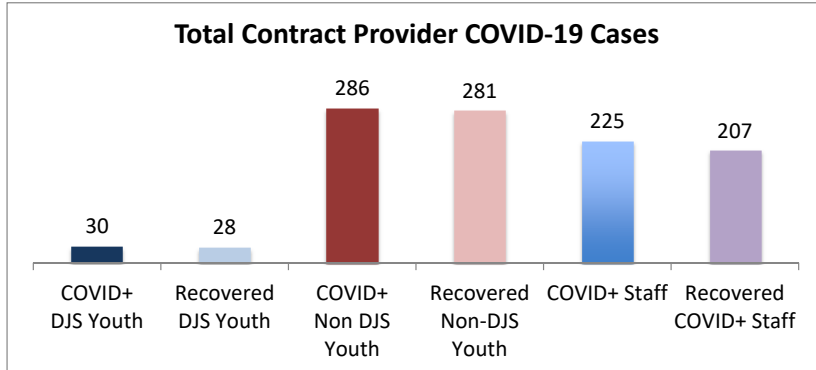


Overall COVID19 Cases To Date, October 15, 2020
