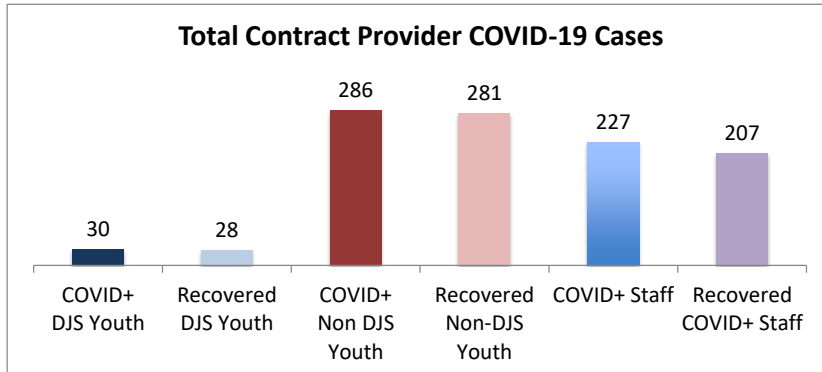


**Overall COVID19 Cases To Date, October 16, 2020**
