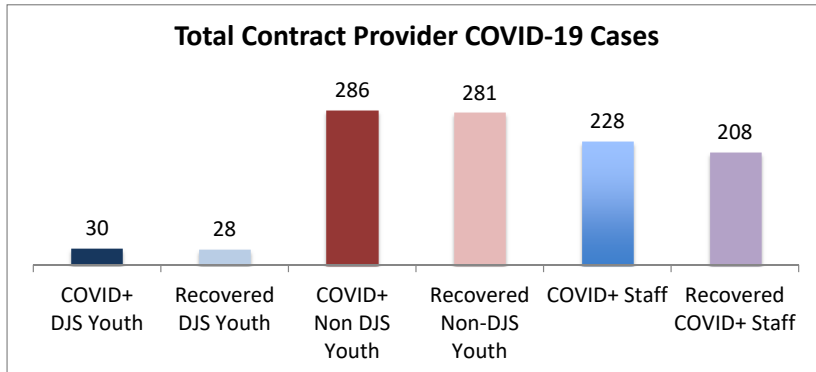


**Overall COVID19 Cases To Date, October 20, 2020**
