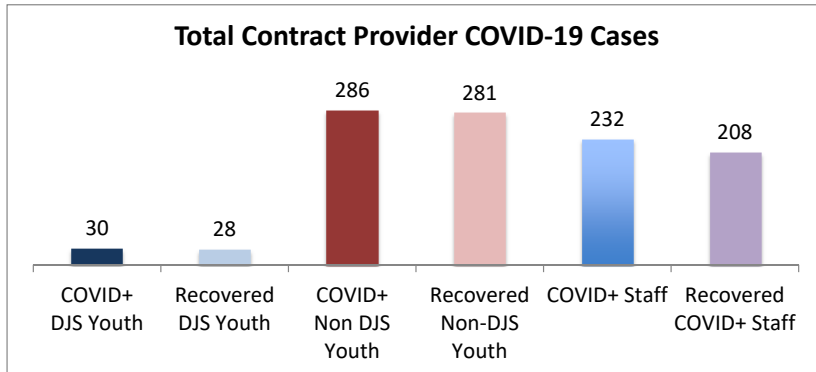


**Overall COVID19 Cases To Date, October 22, 2020**
