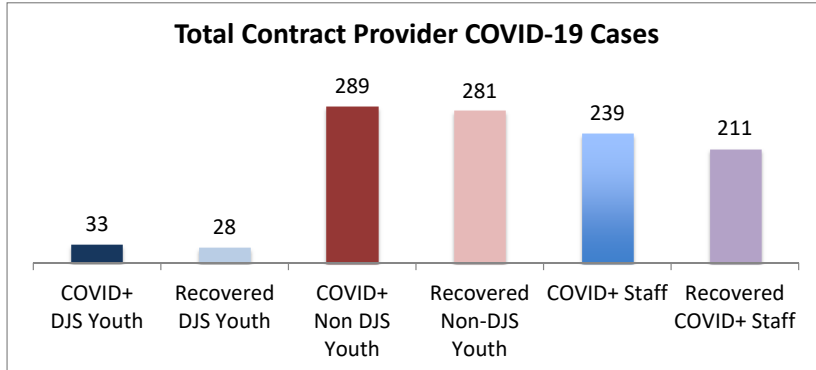


Overall COVID19 Cases To Date, October 28, 2020
