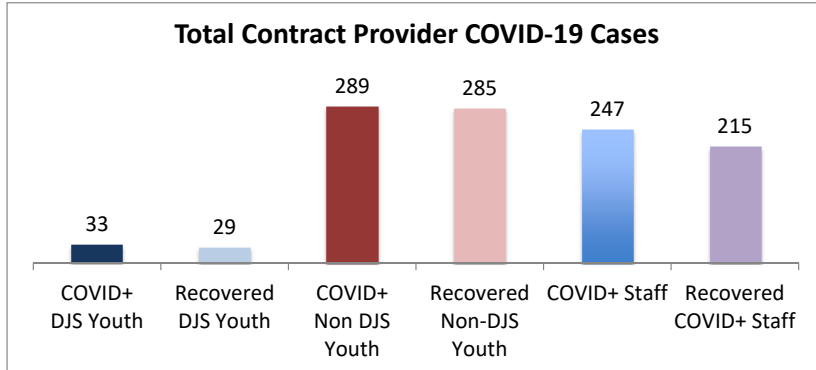


Overall COVID19 Cases To Date, November 4, 2020
