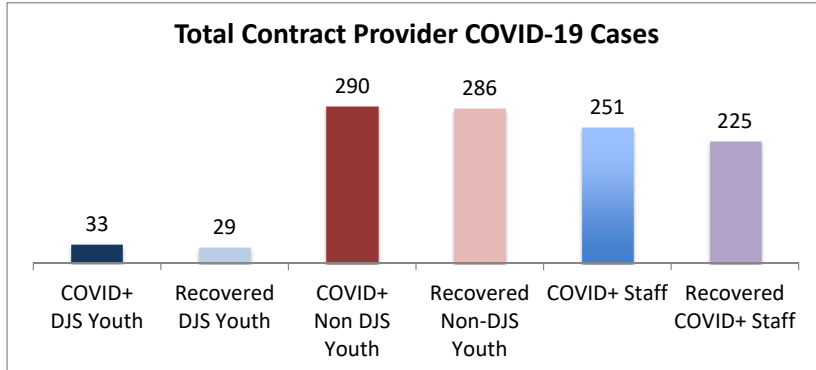


**Overall COVID19 Cases To Date, November 6, 2020**
