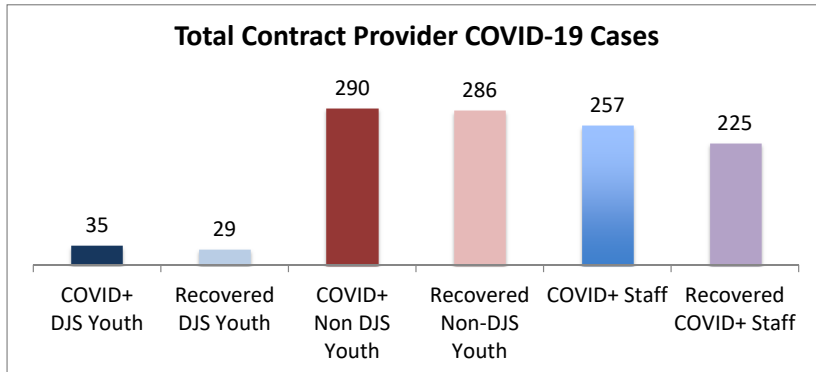


Overall COVID19 Cases To Date, November 9, 2020
