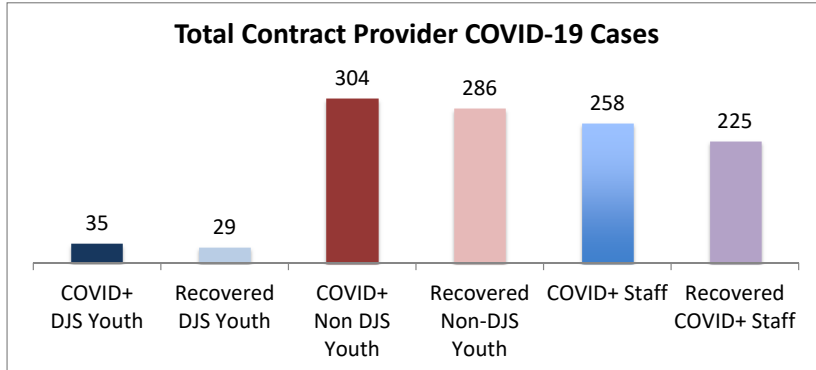


Overall COVID19 Cases To Date, November 10, 2020
