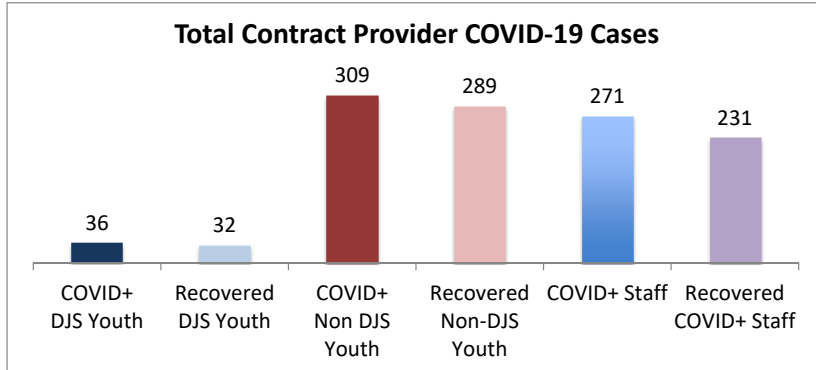


Overall COVID19 Cases To Date, November 18, 2020
