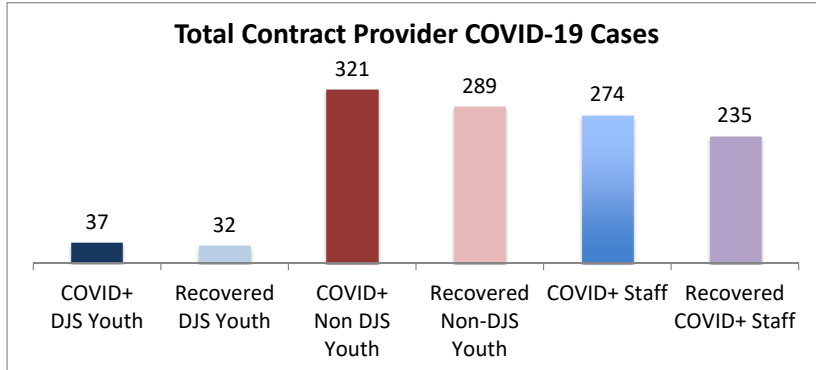


Overall COVID19 Cases To Date, November 19, 2020
