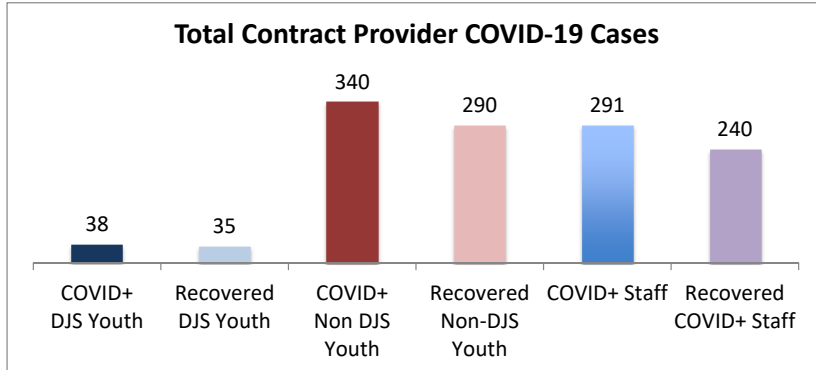


**Overall COVID19 Cases To Date, November 25, 2020**
