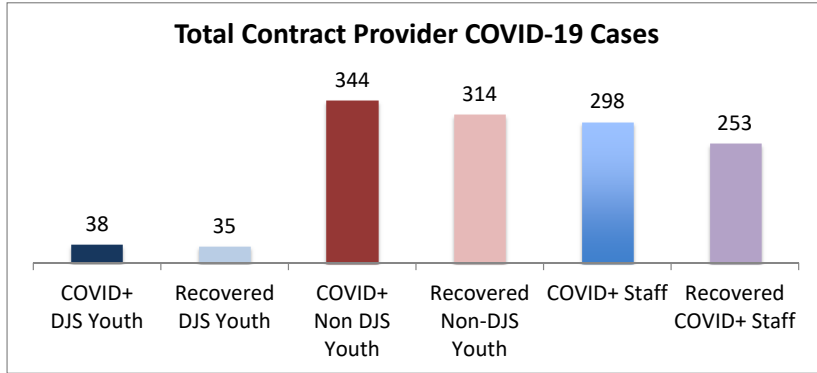


Overall COVID19 Cases To Date, December 1, 2020
