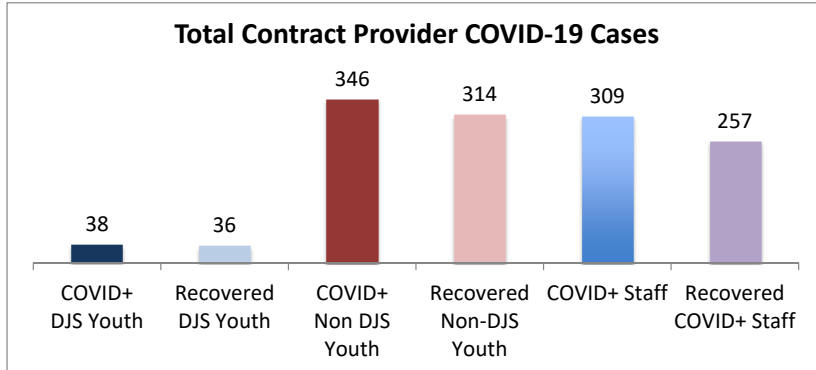


**Overall COVID19 Cases To Date, December 4, 2020**
