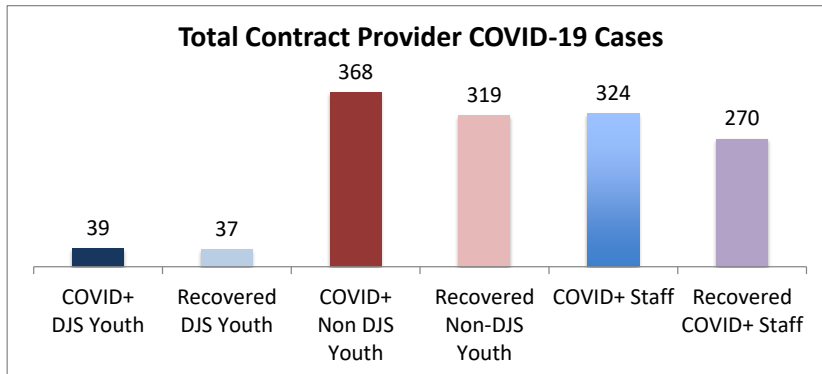


Overall COVID19 Cases To Date, December 14, 2020
