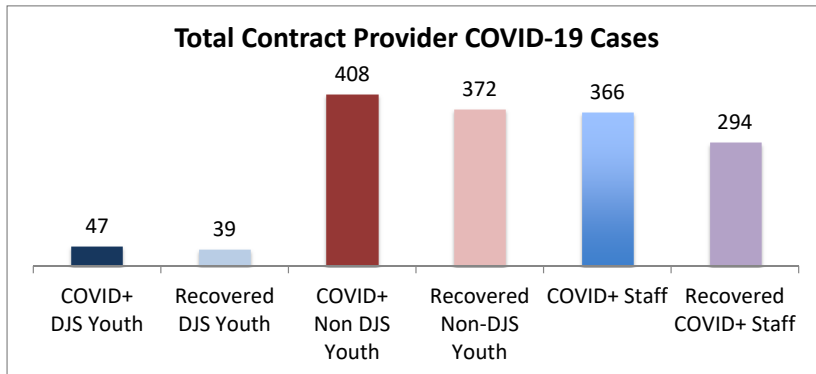


**Overall COVID19 Cases To Date, January 7, 2021**
