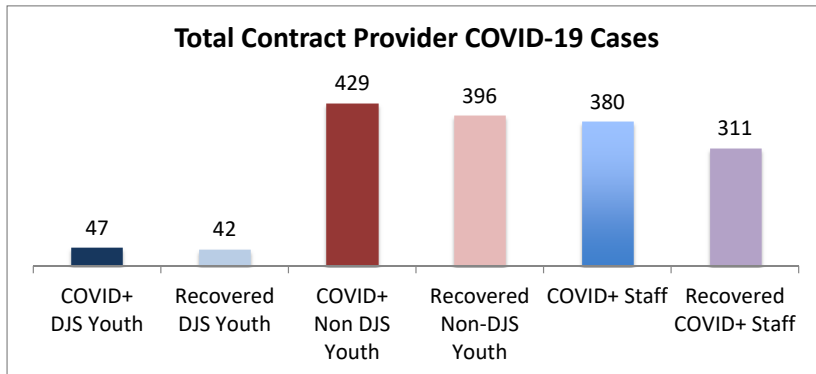


**Overall COVID19 Cases To Date, January 13, 2021**
