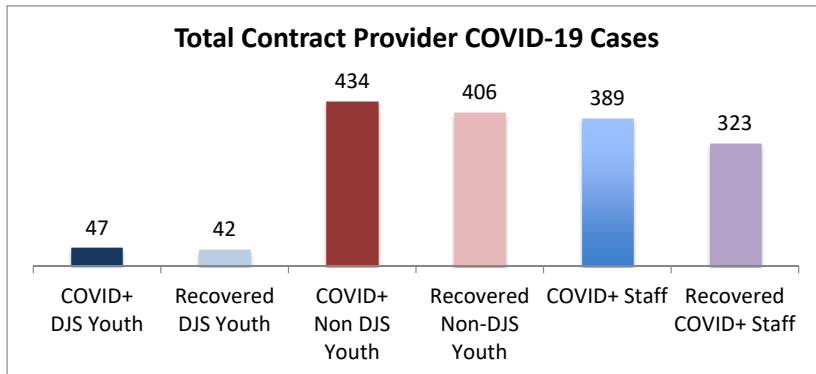


**Overall COVID19 Cases To Date, January 19, 2021**
