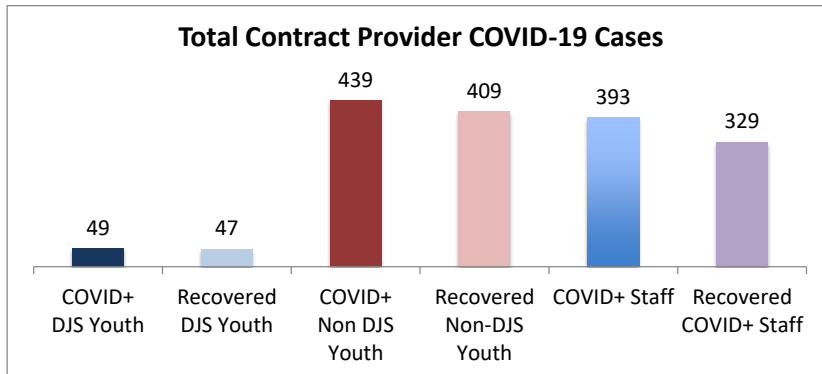


Overall COVID19 Cases To Date, January 21, 2021
