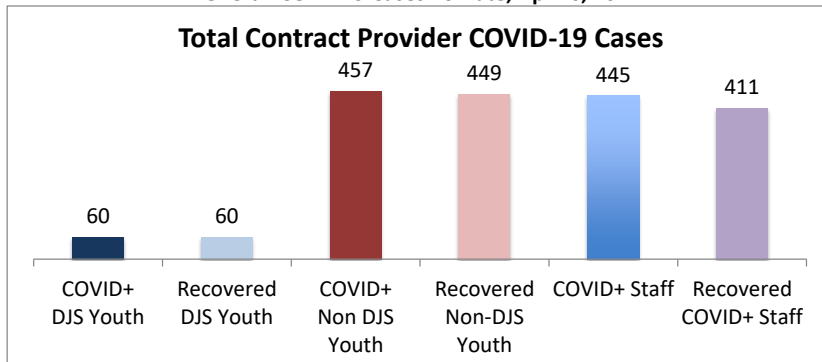


Overall COVID19 Cases To Date, April 6, 2021
