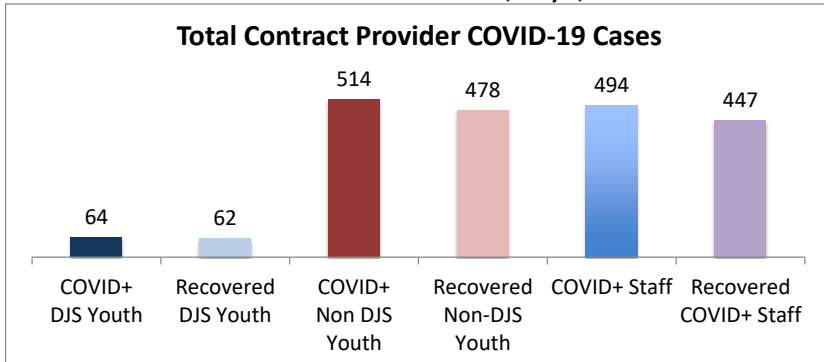


**Overall COVID19 Cases To Date, May 6, 2021**
