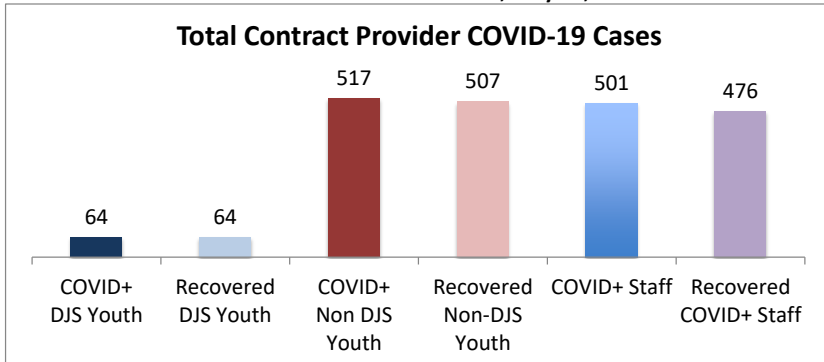


**Overall COVID19 Cases To Date, May 26, 2021**
