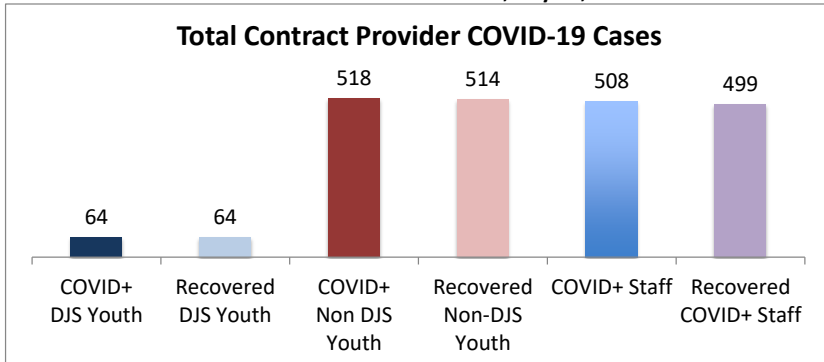


Overall COVID19 Cases To Date, July 14, 2021
