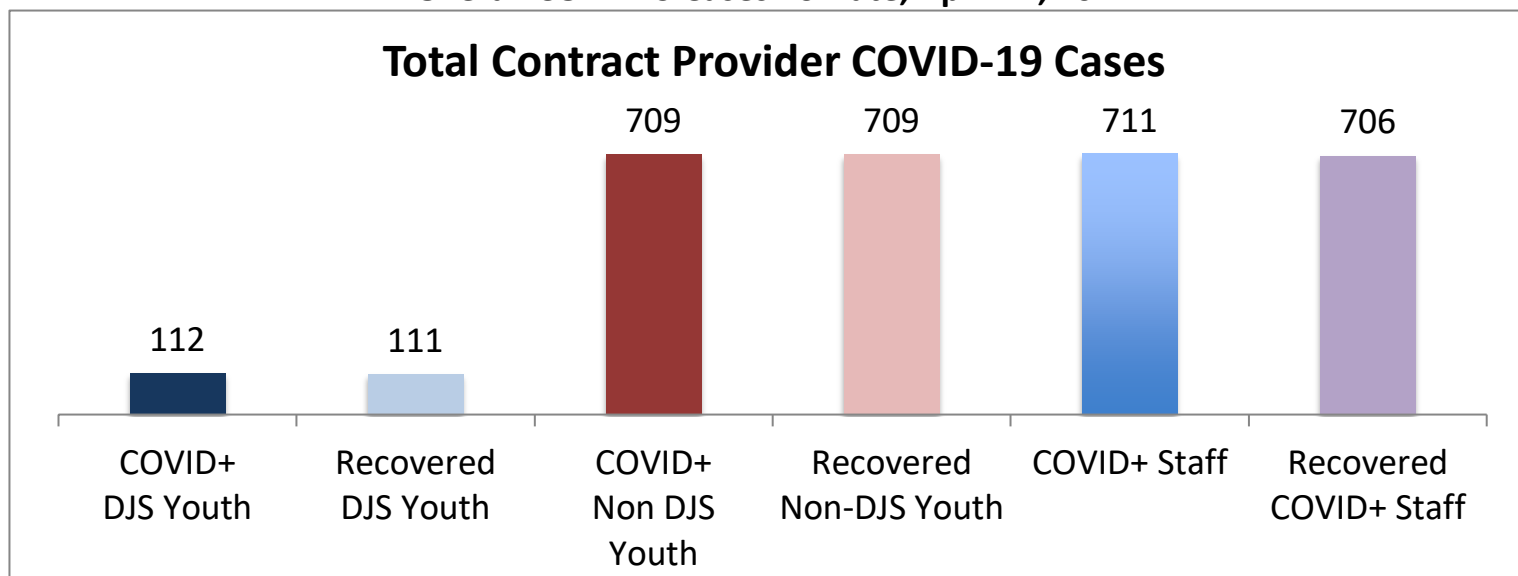


Overall COVID19 Cases To Date, April 12, 2022
