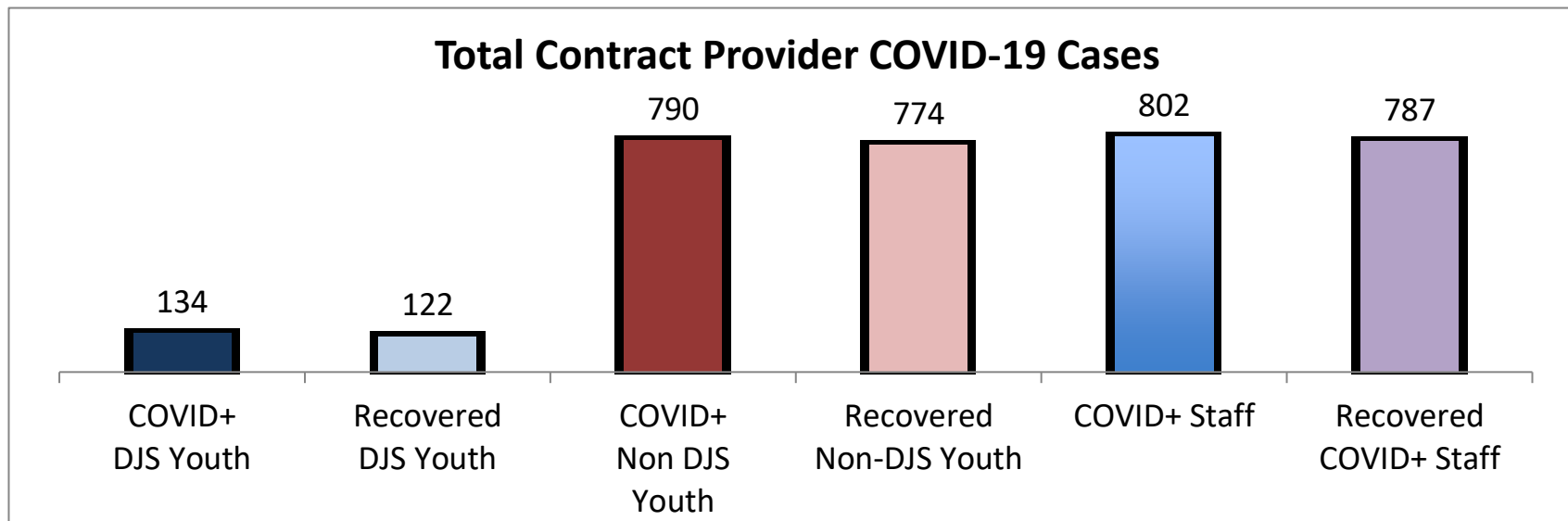


**Overall COVID19 Cases To Date, September 7, 2022**
