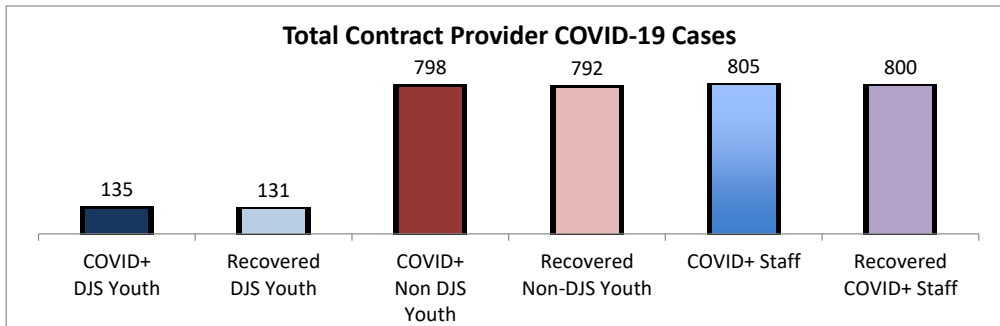


Overall COVID19 Cases To Date, September 29, 2022
