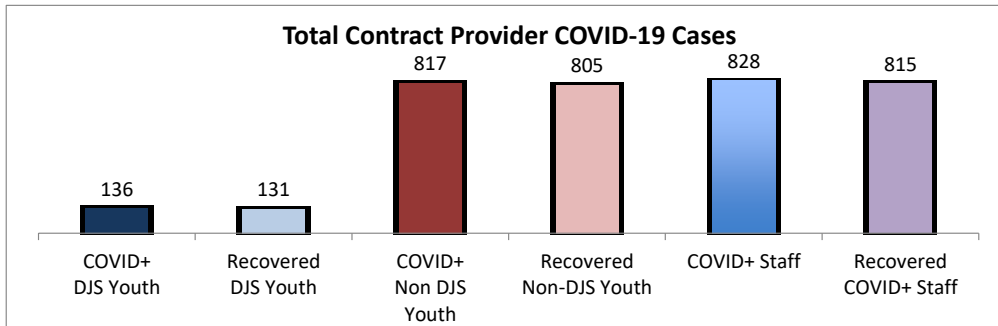


Overall COVID19 Cases To Date, December 2, 2022
