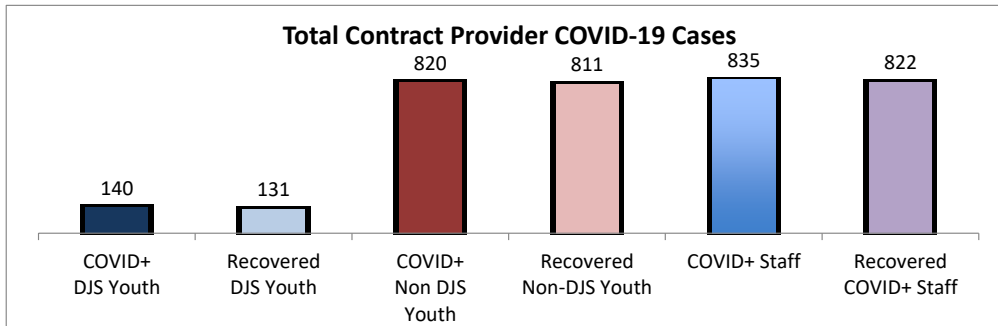


Overall COVID19 Cases To Date, December 9, 2022
