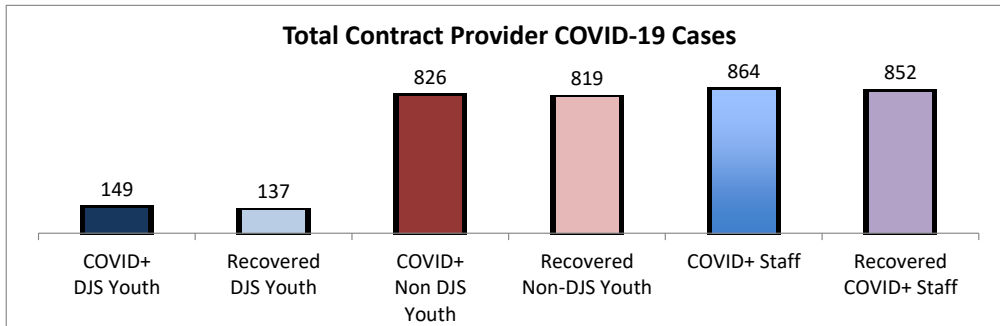


Overall COVID19 Cases To Date, February 2, 2023
